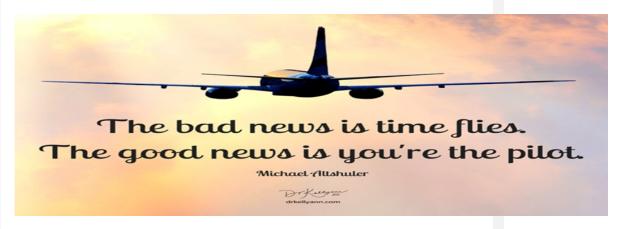


Welcome to the 4th Quarter
